5. Kindly provide a List of teachers receiving financial support year wise for the last five years under each head signed by the principal.
6. Kindly provide a year wise Audited statement of account and highlighting the financial support during the last five years.
7. Kindly note that Receipts/ vouchers of Institution in favor of teachers with amount given should be considered.
8. Kindly note that Without proof of payment on financial support for faculty development, mere name-lists of the faculty will not be considered.

HEI Response:

1. Considering SOP, financial support to faculties for attending FDP is considered one time in SSR data. Also HEI motivates faculties to attend more FDPs and financial support is given. Hence SSR component has single entries and data template has all entries.
